#### Wallet

Through Paytm Wallet using QR code or authorized phone number attached with the account.

#### Cash

Dr. Nature does not accept cash as such but any consumer wants to make purchase through cash, can make his purchase from a Dr. Nature's authorized Centre, in-person. The cash purchase is limited to less than INR 5000/-

#### Point of sale (POS)

- Login into your online account and select the option from Debit Card/ Credit Card/VISA/Master Card/Maestro/Rupay for making payment.
- Follow the instructions on screen to enter the correct details.
- In this case, the you will be required to enter Credit/ Debit/ Maestro/ Rupay card information directly into your website (or secure forms that are loaded by your website during checkout).
